SECTION ONE · THE FOUNDATIONAL PRIVILEGE

01. What is the Foundational Privilege, and what does it grant?

The Foundational Privilege is the founding window before Agaporia opens. It exists only between 1 May and 31 December 2026, and it grants three things. First, priority access to the Soft Opening in Summer 2027, when the estate will receive its first guests at the most intimate scale it will ever operate at. Second, foundational rates locked for five years from that opening, which is the only period in Agaporia's existence when its founding pricing will be available. Third, a permanent position in the Founding Ledger, carrying lifetime Founding membership and the privileges that attend it. The registry of those who recognised what was being built before the world arrived.

After 31 December 2026, none of the three is available again. The closing is structural, written into the architecture itself.

02. What is the Founding Ledger, and what does it mean to be in it?

The Founding Ledger is the permanent registry of the First Circle. It is the document, kept by Agaporia, that records the people who anchored a position before the estate opened. Each entry carries a name, a date, the residency or Pillar secured, and the foundational rate locked. The ledger closes on 31 December 2026 and remains sealed thereafter.

The operational entitlements that come with anchoring a position (priority access, foundational rate, the five-year window) are named in Question 1. Beyond those, being in the Founding Ledger confers two further things.

First, the relationship continues across the decades. A quarterly founder letter carries the estate's development forward in your direction. An annual Personal Impact Report translates each year of stewardship into your cumulative Return on Regeneration™ record. Architectural milestones, regulatory thresholds, and the project's continuing evolution arrive privately, in advance of any public communication.

Second, the gatherings of the First Circle. The Sovereignty Forum convenes the founding cohort on the estate annually. Masterclasses with the people who shape the methodology (the Lead Sleep Specialist, the equine team, the agronomist) open at intervals across the year. Pascal's table, a small private dinner with the founder, recurs by invitation.

And one recognition more: across the decades Agaporia exists, the people in the Founding Ledger will have been the people who made it possible for the estate to open at the standard it intends to hold.

03. What happens between May and December, and after the ledger closes?

The architecture has three phases.

Between 1 May and 31 December 2026, you register your position via the Foundational Privilege form. You select your preferred residency series, duration, and arrival window. There is no payment required at this stage.

Between 1 June and 31 December 2026, Pascal returns to you personally to confirm your residency. This is when the practical detail of your stay is established: dietary architecture, the rhythm of your immersion, the residence assigned to you, anything that belongs in conversation.

Through 1 March 2027, free cancellation applies. After 1 March, the foundational rate is preserved for transfer to a different date within your five-year window where life circumstances require it.

On 31 December 2026, the ledger closes. From that date forward, no new positions can be added to the First Circle. Soft Opening follows in Summer 2027.

04. Why is the First Circle finite, and what is finite about it?

The First Circle is finite because Agaporia is choosing depth over volume with every decision it takes. What is finite is the number of Residences and Pillars that the architecture sustains at the standard the estate intends to hold.

Twenty-four Sovereign Sanctuaries comprise the residential capacity at full operation: sixteen in the New-Build Complex, eight within the restored Masseria. Four Titan Pillar positions exist alongside, each tied to a specific architectural commitment that cannot be replicated.

The First Circle window of May to December 2026 grants the founding cohort priority access to those positions across the five-year period from Soft Opening. After 31 December, the same residences and Pillars will exist as physical and operational realities, but the Foundational Privilege itself, the founding terms that comprise the Priority Residency tier and the Titan Pillar tier, will not.

SECTION TWO · YOUR PRIORITY RESIDENCY

05. How is the Priority Residency priced, and what is included?

Each Priority Residency is priced per residency, two-person occupancy, full package total for the stated nights. The pricing model is anchored to the residency itself, not to the individual guest, which means a couple sharing a Sovereign Sanctuary is priced at the same rate as the residency carries on the Foundational Privilege page.

The Priority Residency is delivered within The Architecture of Presence™, Agaporia's framework for restorative space. The full package includes accommodation in your Sovereign Sanctuary across the stated number of nights, daily Nutrient-Dense Breakfast from the estate's gastronomic atelier (rooted in the 100km Short Circuit and the 2-hectare productive garden), the Dharana Protocol™ treatments matched to the duration of your residency, the Daily Immersions, from dawn movement to guided presence within the agroforestry corridors, rituals that belong to your stay, stripping away the unnecessary to reveal what was always underneath, the Natural Immersions (Equine Resonance, The Regenerative Source, Vino Vivo, and others according to series), unlimited access to the Regenerative Spa, and access to The Conscious Club™ Social Sanctuary that frames every stay.

Founding Guardians in the Sovereign series additionally enjoy a private deep-dive session with the Lead Sleep Specialist, a personal protocol for the architecture of sleep itself, taken home as a permanent instrument of biological sovereignty.

The five-night and seven-night residencies additionally carry a €100 dining credit at The Regenerative Table, the estate's signature evening table where ethically sourced culinary craft becomes the evidence of restoration.

Beyond the residency itself, every stay activates the 4% Restoration Mandate, channelling a fixed allocation to front-line stewardship work beyond the estate. Within the estate's own land, 16 of its 70 hectares are under active rewilding. On departure, a Personal Impact Report translates your stay into documented metrics of soil health, carbon sequestration, and social equity, the beginning of your Return on Regeneration™ record.

What is not included: international travel to and from the estate, additional meals at The Regenerative Table beyond the included credit, any optional extension of your stay beyond the booked duration, and elective experiences that sit outside the protocol. Specific dietary architecture, equine sessions beyond the protocol, and other requests are addressed during the confirmation conversation between 1 June and 31 December.

06. What is the difference between a Regenerative and a Sovereign Residency?

Both series deliver the same five-star regenerative methodology. The Dharana Protocol™ operates identically in both. The Natural Immersions, the Daily Immersions, the gastronomic architecture, the access to The Conscious Club™: all of it is present in either series.

What differs is the residency itself. The footprint, the view, the spaciousness, the ultimate comfort the architecture is permitted to deliver.

The Regenerative series occupies the foundational tier of the estate's residential architecture. Renewal (3 nights) and Retreat (5 nights) inhabit The Core Refuge, a Restorative Sanctuary of 40m². Regenerative Immersion (7 nights) steps up to The Private Shelter, a Restorative Sanctuary of 65m². The series is complete in every protocol respect; what it offers is the focused intimacy of a sanctuary shaped around the work.

The Sovereign series begins where the Regenerative series widens. Escape (3 nights) and Journey (5 nights) inhabit The Private Shelter, a Restorative Sanctuary of 65m². Sovereign Immersion (7 nights) inhabits The Master Residency, a Restorative Sanctuary of 80m². The view extends. The sight lines lengthen. The threshold between residence and land softens. The protocol is identical; the architecture surrounding it is more expansive.

Most Founding Guardians choose the series that matches the architecture they want to inhabit while the protocol does its work. The choice rarely requires deliberation.

07. Three nights, five nights, or seven: how do I know which is right?

Each duration is an architecture.

Three nights is the introduction. The estate receives you, the protocol begins, and you leave with the experience of having entered something. Three nights suits the first encounter, the long weekend, the test of whether what you have been reading is what the place is.

Five nights is the depth. The protocol begins to compound. The Dharana sequence completes its first arc, the body moves past rest into repair, the land starts to feel familiar. Five nights is the most frequently chosen duration among Founding Guardians who already know what they are coming for.

Seven nights is the complete arc. The architecture of the estate is shaped around the seven-night stay; it is what every other duration is a fraction of. By the seventh morning, the boundary between the land and the guest has softened in a way that stays with you for weeks after departure. Seven nights is the residency that returns the most across the five-year window of your foundational rate.

08. The names of the residences: how do they relate to what I am booking?

The form asks you to choose a residency: Regenerative Renewal, Sovereign Journey, Titan Pillar. That choice is the architecture of your stay: what the days are built around, what the protocol delivers, what is included.

The residence names (Lodestar and Stillcrown at The Master Residency; Quietfold, Longview, Slowwater, Goldenhour, Hearthwood, Eveningland at The Private Shelter; and the sixteen Core Refuge names below them) are the physical residences themselves. Each of the twenty-four is a distinct space with its own orientation, its own light, its own relationship to the estate. The names point inward, toward the moments of restoration the body has. The full vocabulary, with the canonical meaning of each name, is held in The Twenty-Four Names, available on request.

The residences operate within The Architecture of Presence™, Agaporia's framework for restorative space: the ordering of light, silence, material, and volume to the biological needs of the person inhabiting them. Each Sanctuary restores the inhabitant as it regenerates the land. Envelopes built to breathe in unison with Nature. Living spaces where every material, bio-active hemp-lime, reclaimed stone, and clay, is a structural act of restoration. The physical integrity of the structure is the biological anchor for a nature-positive outcome. Architecture as covenant.

The Dharana Protocol™ requires an environment of structural integrity. On 70 hectares of Tuscan land in Montefollonico, 16 of them under active rewilding, the estate holds the precise conditions for the restoration of your body's core vitality. Every sanctuary holds atmospheric precision. Stillness and sleep are restorative modalities. Nature has always been the treatment, and every space, every material chosen, every natural element exists in service of that truth.

The work is inward, and the architecture holds the conditions in which the inward turn becomes possible.

When Pascal returns to confirm your residency between 1 June and 31 December, the assignment of the specific residence is part of that conversation. The residency you booked determines the tier of residence; within that tier, the specific named residence is matched to what you are seeking from your stay.

SECTION THREE · THE TITAN PILLARS

09. What distinguishes the four Titan Pillars from one another?

Each Pillar is a different architectural commitment to the estate.

The Legacy Anchor is named stewardship of a specific rewilding sector within the estate's 16 actively rewilding hectares. A defined territory of the estate is mapped to your name, documented across the project's Return on Regeneration™ framework, and recognised in perpetuity as your biological legacy on the land.

The Patron of Sovereignty is the founding patronage of the Resonance Centre: the equine and somatic architecture at the heart of Agaporia's sovereign work. Your patronage shapes the Resonance Centre's physical form; you become the named founder of the space, and the work that emerges from it carries your patronage forward.

The Sovereign Reserve is the 70-hectare estate, exclusively yours, for three uninterrupted nights. The full Biological Engine™, the full team, the full architecture, yours alone for the duration. This Pillar exists for the reader who needs absolute privacy and absolute scale at once.

The Absolute Standard is lifetime sovereignty. Your name permanently inscribed in the estate's founding record, with the highest expression of every commitment Agaporia makes. It is the most asymmetric Pillar in operational scope and in permanence.

Each Pillar attracts a different kind of reader. The conversation with Pascal that follows your inquiry is where the right Pillar and the right reader meet.

10. The value lock: how does the mathematics work?

Three value lock instruments operate within the Foundational Privilege architecture. The mathematics of each is different.

The first instrument is the Priority Residency value lock. Founding Guardians who anchor a Priority Residency between 1 May and 31 December 2026 secure that residency at a 35% to 45% reduction against projected 2027 retail pricing, depending on the residency series and duration. The foundational rate carries the included services intrinsic to each residency with it: €388 in Natural Immersions for the three-night residencies, €732 for the five-night, and €916 for the seven-night, alongside the daily Nutrient-Dense Breakfast and, for five and seven nights, the €100 dining credit at The Regenerative Table. This value lock holds for five years from Agaporia's official opening. It is the structural advantage of registering during the First Circle window, available to every Priority Residency holder by virtue of being in the Founding Ledger before 31 December 2026.

The second instrument is the 5% referral value lock. Founding Guardians who join the First Circle through your introduction become anchored to your record, and you to theirs. Each confirmed referral, up to three, anchors an additional 5% value lock on the foundational rate of both. The First Circle grows by recognition, one introduction at a time.

The third instrument is the up to 50% Titan Pillar value lock. It applies to the Titan Pillar tier and operates on a different basis. Its full mechanics, how the up to 50% is calculated, what it locks against, how the Return on Regeneration™ framework verifies the structural value across time, are documented in the Legacy Prospectus. The Prospectus is the document for any reader considering a Titan Pillar position. The FAQ refers the reader there because the mathematics deserves its own treatment.

11. Inquiring on the Titan Pillar tier: what happens after I check the box?

Checking the Titan Pillar inquiry box on the form signals interest. It commits you to nothing.

Within forty-eight hours, Pascal returns to you personally. If you do not yet have the Legacy Prospectus, it is sent at that point. A private conversation is scheduled (by phone, by video, or in person if circumstances allow) to discuss which Pillar architecture aligns with what you are seeking. The conversation is held without time pressure and without expectation of commitment; if alignment is not present, no commitment follows.

If alignment is present, the formal architecture of the Pillar is established in subsequent conversation: the documentation, the timeline, the operational structure of how the Pillar is brought into the Founding Ledger. No Pillar is secured by form submission alone. Every Pillar passes through founder-to-reader conversation as the operational discipline.

SECTION FOUR · THE LEGACY PROSPECTUS

12. When should I read the Legacy Prospectus, and is it for me?

The Legacy Prospectus is the document that translates the covenant into precise mechanics. It contains the capital deployment across the 70-hectare estate, the Return on Regeneration™ methodology and verification roadmap, the path toward B-Corp certification and its timeline, the structural logic of the up to 50% Titan Pillar value lock, and the architectural detail of each Titan Pillar.

Two readers benefit from it.

Anyone considering a Titan Pillar position should read it before the conversation with Pascal. The Prospectus is the document that the conversation builds on; arriving at the conversation having read it lets the discussion begin at the level of structural alignment.

Anyone in the Priority Residency tier who wants to understand the structural commitments behind the project they are anchoring themselves to. The residency itself does not require the Prospectus, but the reader who wants to know exactly what is being built, with what capital, on what verification timeline, will find every answer there. The Prospectus is the deeper companion to this document.

SECTION FIVE · THE PRACTICAL ARCHITECTURE

13. Free cancellation through 1 March 2027, and after?

Through 1 March 2027, your position is fully cancellable. If you decide before then that what you anchored is not what you want, the matter is closed. No commitment beyond that point requires your continued conviction.

After 1 March, the foundational rate is preserved for transfer. If life circumstances change before your planned arrival, Pascal works with you directly to move the residency to a date that suits the new circumstances. The rate stays. The residency stays. Only the timing flexes.

The architecture exists because the people in the Founding Ledger are people whose lives carry obligations that may shift across years. A residency that meets the shift with care understands its own audience.

14. What if Agaporia's Soft Opening is delayed beyond Summer 2027?

Summer 2027 is the project's working target. Every operational decision to date has been made to honour that target, and the construction architecture, the regulatory pathway, and the partner relationships are all positioned for it.

If a delay occurs (and major construction projects of this scope occasionally do experience delay), the five-year window of your foundational rate begins from Agaporia's actual opening, not from the planned 2027 date. Your residency anchors to the moment Agaporia receives its first guests, whenever that moment arrives. You carry no risk from a delay you did not cause and cannot influence.

The discipline behind this is the same discipline behind the decision not to publish a fixed booking-engine date in the campaign. Agaporia communicates only what is verifiably true. If Summer 2027 holds (and the working assumption is that it will), your residency activates then. If circumstances require a later opening, your residency activates then, with the full five-year window beginning from that later moment.

The Foundational Privilege is the only window in Agaporia's existence when the founding terms apply. Between 1 May and 31 December 2026, the ledger is open. After 31 December, it is sealed.

The estate is being built. The world is preparing to arrive. The First Circle is the people who recognised the work and chose to be present to it from the beginning. If, in reading this, the work has answered questions you had not yet asked, you are already among them.
